SV Presidents Report

PAT FOX, PRESIDENT

Possible Pool Lift at Symphony Village

Many of you have heard that we may be installing a pool chair lift. If this project, which was requested by a resident, proceeds, it would be one chair lift shifted between the two pools. Initially it would be mounted at the indoor pool and moved to the outdoor pool in the summer.

This matter has been handled to date in closed Board meetings as it is a legal matter based upon Federal Housing Administration regulations, which state that a disabled resident can request a "reasonable accommodation," While SV is not an ADA community, we are subject to FHA regulations.

Under the FHA regulations, the HOA can require that the party requesting the equipment pay for it and the cost of the installation. The HOA would be responsible for maintenance, including insurance, and any future replacement.

The Board and GM have been researching the issues associated with a lift and evaluating impacts and costs to the community to see if they are reasonable. At this time, the Board and GM are working with the residents requesting the unit attempting to resolve final details including an initial contract paid for by the resident to test

the thickness of the deck concrete at both pools. This must be at least four inches thick to carry the weight of the unit.

Should that test be successful, and all other requirements agreed to by the requesting residents, the complete package outlining the equipment specs, costs to the requesting residents, user rules, and mandatory user waivers, would then be on the HOA regular Board meeting agenda. The HOA would then be taking ownership of the equipment and accepting the fees provided by the residents to cover the installation expenses.

Governing Documents Revisions

We are almost finished with the update! All comments have been reviewed with many incorporated into the final draft. A very important change—based on resident suggestions—is to shift to two-year Board terms.

Our attorney will be updating the executive summary and the ballot.

As soon as we have final draft documents with the changes highlighted, we will post them on the Website for your review with the attorney's support documents to follow shortly thereafter, if need be.

We will be making copies of this material—both the original and the "revised" and mail to you all along with the ballot. You will have at least 30 days for review of this package before your ballot or proxy is due. Remember, you can submit proxies by mail or drop them off at the Clubhouse in advance. If you choose to attend the meeting that we will schedule, you can submit your ballot in person. These two different forms will be explained in the mailing.

Remember 237 yes votes by households are necessary to approve any change!

Symphony Village Board of Directors Member – Pat Ways

We are happy to announce that Pat Ways has agreed to remain on the board and finish out the remaining year of his term. Pat has been dealing with health issues for the last several months, and we are pleased to say that his health has greatly improved, and he will be able to continue his work on the board.

We would like to thank those of you who expressed interest in serving the remainder of Pat's term and remind you that two seats will be up for election to the board next year.

BOARD OF DIRECTORS HIGHLIGHTS – NOVEMBER 2021

The following motions were made and approved at the November 12 meeting.

Landscape & Irrigation (L&I) Committee Approved Recommendations:

- The Level Green 2022 landscape contract was approved for ~\$254.4K/year.
- The Level Green 2022 irrigation contract was approved for ~\$31.3K/year.
- The plan for a wind sculpture to be installed in the large ceramic pot by the Pavilion was approved for ~\$3K.

Budget & Finance Approved Recommendations:

- The CD maturing at TAB Bank on December 29, 2021 was approved for reinvestment at that bank as a one-year CD for \$125K.
- The 2021 interest will be deposited in the community's operating fund.

COVENANTS COMMITTEE

LANDSCAPE AND IRRIGATION COMMITTEE

Tom McManus, Chair

The Landscape and Irrigation Committee is always on the lookout for residents with an interest in the appearance of the Symphony Village community, and encourage their joining our team. With so many new residents, we are hoping some will recognize an opportunity to help.

We are not overly involved with the day-to-day operation of the contractors, i.e., mowing, fertilizing, chemical treatments, etc.; or irrigation issues and concerns; or work order requests. The day-to-day operations are best left to our Management Team to handle and coordinate.

Our focus is more on the future, on where and how we would like to see SV proceed going forward. Our committee can already see first-hand the early effects of global warming; and we have long understood the need to do even more to protect our environment, rivers, streams, and of course the bay itself. "Sustainable Landscape Practices" equates to less mowings, less irrigation, and fewer chemical applications. Our landscape contractor has calculated that we have approximately twenty-six (26) acres of turf here in the village, all of which receives constant care and maintenance. That is a lot of grass.

It would seem we could do better with less turf, and the corresponding reduction in the supporting services. Therein lies the challenge. People love healthy and well-manicured lawns and grassy views to look at and admire. Our challenge is how we satisfy these competing and conflicting forces. There are lots of experts offering radical suggestions, and some may be very valid; but we represent all the village residents. We must be fair to all and consider everyone's opinions and desires. For that reason, we need the knowledge and experience of all our residents with a passion for these concerns, along with your ideas for dealing with them.

In early 2022, we intend to begin the installation of a small test plot for a future meadow environment in SV, at a location on the hillside of Pond #3, by the corner of Bravo Boulevard and Harmony Way. Our plan is to continue to grow this area over the years to ultimately provide a wildlife-friendly natural habitat for pollinator insects and birds, and a view for all to admire.

Additionally, we have about 1,700 trees to be monitored and tended to, when necessary. Of course, we have a tree services contractor for the heavy lifting, but could always use some knowledgeable help in support of that effort. Finally, we also have oversight responsibilities for our SV-wide irrigation systems. So, if we have any engineers in the SV Community, please consider joining the committee.

It is increasingly important that we, as a community, be more creative and innovative when it comes to where we go from here with our landscaping goals, and how we achieve them. Please consider joining our team to helping figure this out for the benefit of Symphony Village, as well as those around us.

There will be a Home Decorating Contest for Christmas at Symphony Village. Stay tuned for more information.



OPERATIONS COMMITTEE

The Operations Committee is responsible for aiding the HOA Board of Directors (BOD) and the General Manager (GM) regarding management and operation of community common property. We share this responsibility with the Landscape and Irrigation Committee and focus on such things as the Clubhouse, swimming pools, and sidewalks. We meet on the third Thursday of each month.

The Committee is currently assisting the GM in seeking contractors for three major projects: a Request for Proposals (RFP) to recoat the tennis/ pickleball courts; and Requests for Interest (RFI) to upgrade the parking lots and putting green. The Committee will assist the GM with site visits to help determine recommendations to the BOD regarding best courses of action. Most of this work would likely take place in the spring/summer of 2022.

The Committee will have a full plate of important and interesting projects for next year in addition to the actions listed above. We have a subcommittee reviewing our Replacement Reserve Study for an upgrade in 2023. Other projects on the horizon include continuing sidewalk improvements, Clubhouse refurbishment, and storm water management. As our community ages, more attention will need to be paid to our infrastructure.

Sign up for committees in 2022 is already underway, both online and in the Wall Street Room. We would love for new members to join our Committee veterans and make a difference in our great community.



Symphony Village Chain Gang





READING FOR FUN – OCTOBER 2021 REVIEW

The SV Book Club met virtually on Tuesday, October 19, to discuss *When My Name Was Keoko* by Linda Sue Park. The book describes the occupation of Korea by the Japanese before and during World War II. Korean language was banned and all citizens were required to take Japanese names. In the spirit of the book, my attendance list assigns the following identities: Hirohito Sikes, Hanako Withers, Hiroshi & Keiko Buckheit, Hideo & Hoshi Saltiel, Sakura Goldberg, Kazue Olson, Kazuko Kurst and the well-known biruda, "Nils-San." Yasu Volpicelli and Tamiko Decker provided grades separately.

This month's book was chosen to allow the Club to compare Korean occupation during World War II by the Japanese after reading about Nazi occupation in Europe in books like *The Nightingale* (French resistance). The Japanese empire annexed Korea in 1910, so the duration of the occupation was considerably longer than seen in Europe. The story is told in alternating chapters by a Korean brother and sister, both teenagers. They had grown up under the Japanese and had been educated in the Japanese language with stories of the Japanese empire. In fact, use of the Korean language was forbidden and was cause for immediate punishment.

Much like in Europe, the local inhabitants were made to provide supplies to support the Japanese war effort, leaving meager food rations for Korean families. They were also subjected to a fear campaign about atrocities to expect if American soldiers invaded. In fact, school children were trained with sharpened bamboo sticks to resist American soldiers in case of invasion. I became aware of this practice when stationed in Okinawa in the 1970s. The local Ryukan people were inculcated with such a grave fear of Americans that, following the allied invasion in 1945, hordes of civilians committed suicide by throwing themselves off local cliffs.

The two teenagers, Keoko and Nobuo, knew well that the Japanese were their true oppressors and thought many of the rules imposed on them are foolish. But the propaganda movies about Americans gave rise to a fear that an American invasion would not distinguish between the Japanese and their Korean subjects. Luckily there was no invasion but, sadly, we see 75 years later that Americans have much to learn distinguishing between different Asian ethnicities.

As the war goes badly for the Japanese, more strict measures were employed and Korean boys were conscripted to fight for the Japanese forces. Nobuo sees his first airplane and joins the Japanese Air Force in hopes of learning to fly and getting better treatment for his family. He eagerly volunteers for a flying mission, but discovers he has been assigned as a kamikaze pilot. This not only makes the plot interesting, but also reminded me that I had the unusual experience of meeting a Japanese kamikaze pilot in 2005. While not the most decorated kamikaze, his flight training experience was very similar to my own.

The author wrote the story for young adults, which worried me when we selected the book. However, the story was well written and many of the more repulsive Japanese excesses were not told in graphic detail due to the intended audience. The resistance by other members of their family was more surreptitious when compared to European theater novels we have read. Many members of the Korean resistance fled to Manchuria to escape the Japanese. The rise of the Communist Chinese followed closely by the Korean War left many relatives on the North Korean side of the subsequent divide of the peninsula. Korean families were fractured much as they were in Germany, but, of course, they remain so today.

The Book Club found the book easy to read, and it greatly enlightened us about an unfamiliar part of WWII. They enjoyed it very much and graded it 7.87 out of 10.
